#### (PECT) Catalogue Management

Creates workspaces for procurement with an unlimited number of supplier catalogues for goods and/or services.

#### (PECM) Contract Management

Allows for the preparation, review and execution of contracts. Contract management also includes payment features to manage all aspects of contract payment accounting.

#### (PEEP) eProcurement Site

Builds trust in government through transparency on procurement processes, suppliers, pricing and terms.

#### (PEGP) Government Procurement

Supports fiscal discipline on large scale government acquisitions including tendering, eProcurement, contract and spend management.

#### (PEPM) Payment Management

Payments process and collection management are initiated by the expense voucher from any source (regular transactions, payroll, contract management, etc.)

#### (PEPR) Purchasing and Expenditure

Core government purchase and commitment cycle: requisitions, purchase orders, goods receipt, goods returned, expenses and payment vouchers.

Governments raise revenue and collect receipts through a number of means. This includes non-tax revenue, taxation and billing and receipts.




Public Expenditure Management
